MORTGAGE

THIS MORTGAGE IS DATE 04-13-1987, BETWEEN Marian M. Kirby, ,divorced and not since remarried, ("GRANTOR"), whose address is 6871 W. 175th Place, Tinley Park, I (Inc. in 60477; AND Heritage Bremen Bank And Trust Company ("LENDER"), whose address is 17500 Oak Park Avenue, Tinley Park, Illinois 60477.

GRANT OF MORTGAGE. For value bis consideration, Grantor mortgages and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property, logether with all existing or subsequently erected or utilized buildings, improvements and fixtures, all appurtenances, all rights relating to the real property (including minorals, oil, gas, water, and the like), and all ditch rights (including stock in utilities with ditch or irrigation rights) logated in COOK County, State of lilicola (the "Real Property"):

Lender. The word "Lender" means Heritage Bromen Bank And Trust Company. The Lender is the mortage under this Mortgage.

Mortgage. The word "Mortgage" means this Mortgage between Granter and Lender, and includes without limits lion all assignments and security interest provisions relating to the Personal Property and Rents.

Note. The word "Note" means that certain note or credit agreement dated 04-13-1987 in the original princip. I amount of \$5,221.58 from Borrower to Lender, together with all renewals of, extensions of, modifications of and substitutions for the note or agreement. The interest rate on the Note is 11.000%. The Note is payable in 60 Monthly payments of \$113.63. The currently scheduled final payment of principal and interest on the Note will be due on or before 04-20-1992.

Personal Property. The words "Personal Property" mean all equipment, fixtures, and other articles of personal property cwild by Grantor, now or subsequently attached or affixed to the Real Property, together with all accessions, parts, and additions to, all replacements of, and all substitutions for any of such property, and together with all proceeds (including insurance proceeds and refunds of premiums) from any sale or other dispositions of such property.

Property. The word "Property" means collectively the Real Property and the Personal Property.

Real Property. The words "Real Property" mean the real property described above in the "Grant of Mortgage" section.

Related Documents. The words "Related Documents" mean and include any promissory notes, loan agreements, guaranties, security agreements, and all other documents executed in connection with this Mortgage or the Indebtedness, whether now or hereafter existing.

Rents. 'The word "Rents" means all rents, revenues, income, issues, and profits from the Real Property and the Personal Property.

THIS MORTGAGE, INCLUDING THE ASSIGNMENT OF RENTS AND THE SECURITY INTEREST IN THE RENTS AND PERSONAL PROPERTY, IS GIVEN TO SECURE PAYMENT OF THE INDEBTEDNESS AND PERFORMANCE OF ALL OBLIGATIONS OF GRANTOR UNDER THIS MORTGAGE AND IS GIVEN AND ACCEPTED ON THE FOLLOWING TERMS:

Duty to Maintain. Grantor shall maintain the Property in first class condition and promptly perform all repairs and maintenance necessary to preserve

Hazardous Substances. Grantor represents and warrants that the Property never has been, and never will be so long as this Deed of Trust remains a lien on the Property, used for the generation, manufacture, storage, treatment, disposal, release or threatened release of any hazardous substance, as those terms are defined in the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, 42 U.S.C. Section 9801, at seq. ("CERCLA"). Grantor agrees to indemnity and hold harmless Lender against any and all claims and losses resulting from a breach of this provision of the Deed of Trust.

Nulsance, Waste. Grantor shall neither conduct or permit any nulsance nor commit or suffer any strip or waste on or to the Property or any portion thereof, including without limitation removal, or alienation by Grantor of the right to remove, any timber, minerals (including oil and gas), or soil, or gravel or rock products.

Removal of improvements. Grantor shall not denrolled or remove any improvements from the Real Property without the prior written consent of Lender. Lender shall consent if Grantor makes arrangements satisfactory to Lender to replace any improvements which Grantor proposes to remove with improvements of at least equal value.

Lender's Right to \$7.65. Lender and its agents and representatives may onter upon the Real Property at all reasonable times to attend to Lender's interests and to inspect the Property.

Compilance with Qovernmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the Property. Grantot may confest in good faith any such law, ordinance, or regulation and withhold compliance during any proceeding, including appropriate appeals, so long as Grantor has notified Lender in writing prior to doing so and Lender's interests in the Property are not joopard zer. Lender may require Grantor to post adequate security or surety bond (reasonably satisfactory to Lender) to protect Lender's interest.

Duty to Protect. Grantor shall do all other acts, in addition to those acts set forth above in this section, that from the character and use of the Property are reasonably necessary to protect and preserve the Property.

DUE ON SALE - CONSENT BY LENDER. Lancer may at its option, declare immediately due and payable all sums secured by this Moltgage upon the sale or transfer of all or any part of the Roal Property, without the Lendor's prior written consent. TAXES AND LIENS.

Payment. Grantor shall pay when due before they become delinquent at tayus, special taxes, assessments, water charges and sewer service charges levied against or on account of the Property, and shall pay when due all deline for work done on or for services rendered or material furnished to the Property. Grantor shall maintain the Property free of all liens having priority over or equal to the interest of Lander under this Mortgage, except for the lien of taxes and assessments not due, and except as otherwise provided in the following paragraph.

Right To Contest. Grantor may withhold payment of any tax, assessment, or claim in connection with a good faith dispute over the obligation to pay. so long as Lender's interest in the Property is not jeopardized. Evidence of Payment. Grantor shall upon domand furnish to Lundor cylderica of paymont of the taxes or assessments and shall authorize the appropriate gevenimental official to deliver to Lender at any time a written statement of the taxes and assessment against the Property.

Notice of Construction. Grantor shall notify (lander at least 15 days bulleto any work is communiced, any services are furnished, or any materials are supplied to the Property, if any mechanics, materialmens, or other construction lien could be asserted on account of the work, services, or materials and the cost exceeds \$1,000.00. Grantor will on request lurnish to Lender advance assurances patisfactory to Lender thut Grantor can and will pay the cost of such improvements.

PROPERTY DAMAGE INSURANCE

Maintenance of insurance. Grantor shall procure and maintain policies of the insurance with standard extended coverage endorsements on an actual cash value basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgagee clause in favor of Lender. Policies shall be written by such insurance companies and in such form as maybe reasonably acceptable to Lender. Grantor shall deliver to Lender certificates of coverage from each insurer containing a stipulation that coverage will not be cancelled or diminished without a minimum of 10 days prior written notice to Lender.

Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property. Lender may make proof of loss if Grantor falls A to do so within 15 days of the casualty. Lender may, at its election, apply the proceeds to the reduction of the indebtedness, payment of any liententing the Property, or the restoration and repair of the Property. If Lender elects to apply the proceeds to restoration and repair, Grantor shall repair or replace the damaged or destroyed improvements in a manner satisfactory to Lander. Londer shall, upon satisfactory proof of such expenditure, pay or reimburso Grantor from the proceeds for the reasonable cost of repair or restoration if Grantor is not in default hereunder. Any proceeds which have not been disbursed within 180 days after their receipt and which Londer has not committed to the repair or restoration of the Property shall be used to pay any amounts owing to Lender under this Dead of Trust, then to prepay accrued interest, and then principal of the Indebtedness. WARRANTY; DEFENSE OF TITLE.

Title. Grantor warrants that it holds merchantable title to the Property in fee simple, free and clear of all liens and encumbrances other than those set forth in any policy of title insurance issued in favor of, and accepted by, Londer in connection with this Mortgage.

Defense of Title. Subject to the exception in the paragraph above, Grantor warrants and will forever defend the little to the Property against the lawful claims of all persons. In the event any action or proceeding is commenced that questions Grantor's title or the interest of Lender under this Mortgage, Grantor shall defend the action at its expense. Grantor may be the nominal party in such proceeding but Lender shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Grantor will deliver, or cause to be delivered, to Lender such instruments as may be requested by it from time to time to participation.

Compliance With Laws. Grantor warrants that its usnof the Property complies with all existing applicable laws, ordinances, and regulations of governmental authorities.

CONDEMNATION.

Application of Net Proceeds, if all or any part of the Property is condemned, Londor may at its election require that all or any portion of the net proceeds of the award shall mean the award after payment of all reasonable costs, expenses, and attorneys' fees necessarily paid or incurred by Grantor, or Londor in connection with the condemnation.

Proceedings. It any proceed we in condemnation are filled, Grantor shall promptly notify Lender in writing and Grantor shall promptly take such steps as may be necessary to determine action and obtain the award. Grantor may be the nominal party in such proceeding but Lender shall be entitled to participate in the proceeding and the proceeding by counsel of its own choice, and Grantor will deliver or cause to be delivered, to Lender such instruments as may be counseled by it from time to time to participation.

IMPOSITION OF TAX BY STATE.

State Taxes Covered. The following small constitute state taxes to which this section applies: (a) a specific tax upon this type of Mortgage or upon all or any part of the Indebtedness secured by this Mortgage; (b) a specific tax on any Grantor which the taxpayer is authorized or required to deduct from payments on the Indebtedness secured by this type of Mortgage; (c) a tax on this type of Mortgage chargeable against the Lender or the holder of the Note; and (d) a specific tax on all or any portion of the Indebtedness or on payments of principal and interest made by any Grantor.

If such a failure is curable and if Grantor has not been given a notice of a breach of the same provision of this Mortgage within the proceeding 12 months, if may be cured (and no event of default will have occurred) if Grantor, after receiving written notice from Lender demanding cure of such failure: (a) cures the failure within 15 days; or (b) if the cure requires more than 15 days, immediately initiates steps sufficient to cure the failure and thereafter continues and completes all reasonable and necessary steps sufficient to produce compliance as soon as reasonably practical.

Breaches. Any warranty, representation or statement made or furnished to Lender by or on behalf of Grantor under this Mortgage, the Note or the Rolated Documents is, or at the time made or furnished was, talse in any material respect.

Termination of Existence. The death of any Grantor (if Grantor is an individual), insolvency of Grantor, appointment of a receiver for any part of Grantor's property, any assignment for the benefit of creditors, the commencement of any proceeding under any bankruptcy or insolvency laws by or against Grantor, or the dissolution or termination of Grantor's existence as a going business (if Grantor is a business).
