FOURTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR INVERNESS ON THE PONDS TOWNHOME CONDOMINIUM ASSOCIATION

THIS FOURTH AMENDMENT TO DECLARATION made and entered into by FIRST ILLINOIS BANK OF WILMETTE, not individually, but as Trustee under Trust Agreement dated the 15th day of April And known as Trust No. TWB-0372 (hereinafter referred to as "Trustee").

WHEREAS, the Trustee to the legal title holder of and now wishes to so annex and add to said Parcel and Property and submits to the provisions of Act as part of the Condominium the followings real property (the "Additional Property") described on Schedule attached hereto;

NOW, THEREFORE, FIRST ILLINOIS SANK OF WILMETTE, as Trustee aforesaid and not individually, as the legal title holder of the Additional property, and for the purpose above set forth, hereby declares that the Declaration be and sereby is amended as follows:

- 1. The Additional Property is hereby annexed to the Parcel and Property as defined in Article I of the Declaration and, together with all improvements and structures erected, constructed or contained thereon, is hereby submitted to the provisions of the Act as part of the Condominium in accordance with, and shall be deemed to be governed in all respects by, the terms and provisions of the Declaration.
- 2. Exhibit "A" of the Declaration is hereby amended by deleting said Exhibit "A" and substituting Exhibit "A" attached
- Exhibit "B" of the Declaration is hereby amended by deleting Sheet 1 of said Exhibit "B" and substituting therefor of Exhibit "B-1" attached hereto, and by the Sheet 1 of 13 of Exhibit "B-1" attached hereto, and addition of Sheets 12, 13 out of 13 attached hereto.
- The percentage of ownership in Common Elements appurtenant to each Unit (as that term is defined in the Declaration) is hereby shifted to the respective percentages set forth in Exhibit "C" attached hereto, and Exhibit "C" of the Declaration is hereby amended by deleting said Exhibit "C" and substituting Exhibit "C" attached hereto.
- The additional common elements annexed by this instrument are hereby granted and conveyed to the grantees of all Units, including the grantees of Units heretofore conveyed, all as set forth in the Declaration.
