

Sec. 6321. Lien For Taxes.

If any person flable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interpay the same after comme, the amount (incoding any inter-set, additional amounts that may accrue in addition therets) shall be a lien in faith of the United States upon all properly and rights to properly, whether risk or personal, belonging

Unless another tisks is specifically fixed by law, the flen Imposed by saction 6921 whalf arise at the time the assess: is made and shall continue until the liability for the amount so d (or a judgment against the taxpayer arising out of ush liability) is satisfied or becomes unenforceable by reason

Sec. 4323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security In-reals, Sechanic's Lienors, And Judgment Lien Braditors. — The ilen imposed by section \$321 snam not be visit as against any purchaser, holder of a security not be visit as against any purchaser, holder until notice hanlo's lienor, or judgment lien creditor until netice thereof which meets the requirements of subsection (f) has on filed by the Secretary.

(2) Disclosure of amount of outstanding lien. - If a notice of lien has been filed pursuant to section \$323(f), the amount of the outstanding obligation secured by such lien may be disclosed to any person who furnishes satisfactory written evidence that he has a right in the property subject to such lien or intends to obtain a right in such property.
