All payments are to be applied, first, to any late charges due, then interest, and the balance to principal, until said inderridness is paid in full; (2) The performance of other agreements in said Note and Construction Loan Agreement dated APRIL 21ST, 1987, which are hereby incorporated herein and made a part hereof, and which provides, among other things, upon ten days notice from the Mortgagee for an additional monthly payment of one-twelfth (1/12) of the estimated annual taxes (unless the Mortgagee has piedged an interest bearing savings account to satisfy estimated taxes) assessments, insurance premiums and other charged upon the mortgaged premises, and (4) The performance of all of the covenants and obligations of the Mortgagor to the Mortgagee, as contained herein and in said Note and Construction Loan Agreement dated APRIL 21ST, 1987.
