SPECIAL COMMISSIONER'S DEED 87227644

THIS INDENTURE, made this 13th day of April, 1987, between Thomas Johnson, a duly appointed and qualified Special Commissioner of the United States District Court, Northern District of Illinois, Eastern Division, party of the first part, and the Administrator of Veterans Affairs, an Officer of the United States of America, Washington, D.C. 20420, part of the second part, WITNESSETH:

WHEREAS, in pursuance of a decree entered on August 13, 1986, by the United States District Court, Northern District of Illinois, Eastern Division, in a certain cause then pending therein, wherein Fleet Mortgage Corp. was plaintiff, and Alice Thomas, et al.

were defendants, Case No. 86 C 3232, and wherein Thomas Johnson, Special Commissioner of said United States District Court duly advertised according to law the premises hereinafter described for sale at public vendue to the highest and best bidder for cash at the hour of 4:00PM on the 18th day of September, A.D. 1986, at the Room 2302, Daley Center, in the City of Chicago, County of Cook, and State of Illinois, and

WHEREAS, under the law, rules and order of said Court, a duly appointed and qualified Special Commissioner of said Court is empowered and directed to issue a proper deed of conveyance; and

WHEREAS, said premises have not been redeemed from said sale;

NOW THEREFOR, the said party of the first part does hereby convey unto the said party of the second part, its successors and assigns, the premises which are situated in the County of Cook, State of Illinois, described as:
