

Excerpts From Internal Revenue, Code

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interset, additional amount, addition to tax, or assessable penalty, together with any costs that may accrue in addition thereto) shall be a lien in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person.

Sec. 6322. Period Of Lien.

Unless another data is specifically fixed by law, the lien imposed by section 6321 shall arise at the time the assessment in made and shall continue until the liability for the amount so assessed (or a judgment against the texpayer arising out of such liability) is satisfied or becomes unenforceable by reason of lapse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Burchaser's, Holders Of Security Interests. Mechanic's Lienors, And Judgment Lien Creditors. — The Hen imposed by section 8321 shall not be write as against any purchaser, holder of a security interest, inchenic's lienor, or judgment lien craditor until notice thereof which meets the requirements of subsection (f) has been file the Secretary.

in Piace For Filing Notice: Form.-

(1) Place For Filing - The notice referred to in aubection (a) shall be filled -

(A) Under State Laws

(i) Real Property - In the case of real property, in one office within the State (or the county, or other governmental subdivision); as designated by the laws of such State, in which the property subject to the lien is situated; and

(II) Personal Property - In the case of personal property, whether tangible or intangible, in one office within the State for the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is altuated; 2011/11/12

(B) With Clerk Of District Court - In the office of the clerk of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has not by law designated one office which meets the requirements of subparagraph (A), or

(C) With Recorder Of Deeds Of The District Of Columbia - In the office of the Recorder of Deede of the District of Columbia, if

(3) Form - The fam and content of the natice referred to in subsection (a) shall be prescribed by the Secretary. Such notice shall be valid notwithstanding any other provision of law or garding the form or content of a natice of lien.

(9) Reffling Of Notice. - For purposes of this section -

(1) General Rule. - Unless notice of tien is refiled in the manner prescribed in paragraph (2) during the required: refilling period, such notice of iten shall be treated as that on the date on which it is filled (in accordance with subsection (f)) after the expiration of such refling period.

(2) Place For Filing. - A notice of lien reflied during the required telling period shall be affective only.

6325. Release Of Lien Sec. Discharge Of Property,

(a) Release Of Liefs. - Subject to such regulations as the Secretary may prescribe, the Secretary shell issue a certificate of release of any lien imposed with respect to: any internal revenue tax not later than 30 days after the day on:

(1) Liability Satisfied or Unenforceable - The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or hear

(2) Band Accepted - There is furnished to the Secretary and accepted by him a bond that is conditioned upon the payment of we amount assessed, together with all interest in respect thereof, within the time prescribed by law (including any, extention or such time), and that is in accordance with such requirements existing to terms, conditions, and form of the bond and suration ing on, as may be specified by such regulations.
