

Sec. 6321. Lien For Taxes.

If any person flable to pay any tax neglects or refuses in gay the same after demand, the amount (including any interest, additional amount, addition to tax, or assessable penalty. together with any costs that may accrue in addition thereto) shall be a lien in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person.

Sec. 6322, Period Of Lien.

Unless another date is specifically fixed by faw, the lien imposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability for the amount so assessed (or a judgment against the taxpayer arising out of such liability) is satisfied or becomes unenforceable by reason of tapes of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(Purchaser's, Holders Of Security Interests, Mechanic's Lienore, And Judgment Lien Creditors. - The ilen imposed by section 521 shall not be valid as against any purchaser, holder of a security interest, mechanic's lienor, or judgment lien creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Bacratary.

(n) Place For Filing Notice; Form.-

(1) Place For Filing . The notice referred to in subaction (at shall be filed -

(A) Under State Laws

(i) Real Property - In the case of real property, in one office within the State (or the county, or other governmental aubidivision), as designated by the laws of such State, in which the property subject to the lien is situated; and

(ii) Personal Property - in the case of personal property, whether tangible or intengible, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the Hen is situated;

(8) With Clark Of District Court - In the office of the clark of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has not by law designated one office which meets the requirements of subparagraph (A), or

(C) With Recorder Di Deeds Of The District Of Columbia - In the affice of the Recorder of Deeds of the District of Columbia, if the property subject to the lien is situated in the District of Columbia 1.

(3) Form - The and content of the notice referred to in subsection (i) shall be prescribed by the Secretary. Such notice them to valid notwithstanding any other provision of law regarding the form or content of a notice of lien.

(g) Retiting Of Notice. - For purposes of this section -

(1) General Rule. - Uniess notice of fien is reiffed in the manner prescribed in paragraph (2) during the required refilling period, such notice of fian shall be treated as filed on the date on which it is filed (in accordance with Subsection (f)) after the expiration of such relating period.

(2) Place For Filing. — A notice of then retited during the required retiting period shall be offective only -

(A) If -

(i) such notice of lian is relified in the office in which the prior notice of tien was filed, and

(ii) in the case of real property, the fact of refiling is entered and recorded in an index to the extent required by subsection (f) (4), and

(B) In any case in which, 90 days or more prior to the date of a retiling of notice of lien under subparagraph (A), the Secretary received written information (in the manni prescribed in regulations lasted by the Secretary concerning a change in the taxpayer's residence, if a notice of such Hen is also filled in accordance with subsection (f) the State in which such residence is legaled.

in Required Reliting Period. - in the case of any notice of lien, the term "required refilling period" means -(A) the one-year paried anding 30 days after the expiration of 6 years after the date of the assessment of the tax, and (8) the one-year period ending with the expiration of 6 years after the close of the preceding required refilling period for (Buch notife at their - C ; 1111

tal Release Of Lien. - Subject to such regulations as the Secretary may prescribe, the Secretary shall issue a certificate of release of any lien imposed with respect to any internal revenue tax not later than 30 days after the day on

(1) Liability Satisfied or Unenforceable - The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has

become legally unenforceable; or

(2) Bond Accepted - There is furnished to the Secretary and accepted by him a bond that is conditioned upon the payment of the amount assessed, together with all interest in respect thursof, with the time prescribed by law (including any extens on of such time), and that is in accordance with such requires. 40% of sking to terms, conditions, and form of the bond and sureties inervia, as may be specified by such regulations.

(i) Disclosure of Certain Returns and Return Information For Tax Administration Purposes, - 17

(2) Disclosure of amount of autstanding lien. - If a notice of lien has been filed pursuant to section 5323(f), the amount of the outstanding obligation secured by such tien may be disclosed to any person who fulfilishes sabsfactory written evidence that he has a right in the property subject to such lien or intenda to obtain a right in such property.
