tend, enforce payment of, compromise, settle and adjust any and all indebtednesses owing to me and to receive payment therefor and to give full and complete receipts and discharges; to make, draw, sign, receive, endorse, negotiate and collect any and all checks. drafts, bills of exchange and other instruments for the payment of money; to withdraw moneys from accounts in my name in any and all banks, and to open and maintain any such accounts, and to sign checks, drafts, and any and all other orders for the payment of money; to lease, renew, give up, enter, place property in, or remove it from, any safe deposit box or vault in my name wheresoever located; to invest and reinvest any moneys or other assets belonging to me in any property or assets of any character whatsoever; to lend moneys beinging to me; to exercise any voting rights which I may have in respect of stocks or other securities: to purchase, sell or redeem on my behalf any securities, including securities of any sort issued by the United States Government, or any division, agency, department or authority thereof; to borrow money on my behalf, and to execute and deliver regotiable or nonnegotiable notes or other obligations therefor, with or without security; to receive on my behalf, and to give full and complete receipts and acquittances for, any and all legacies, bequests devises, inheritances or other distributions of whatsoever chartacter to which I may at any time become entitled; to execute and/O file Federal or State income and gift tax returns on my behalf; and generally to do any and all other acts and things on my behalf as fully and with the same force and effect as I, myself, might or could do if personally present at the doing thereof; and I hereby

ratify and confirm all that my said attorney shall do or cause to be done under or by virtue of the powers hereinabove conferred upon Joseph Mazurek.

This power of attorney shall be continuing, and any person, firm or corporation dealing with my said attorney shall be fully protected in relying or acting thereon, prior to receipt of express notice of the revocation thereof, whether by operation of law or otherwise, and shall not be required to see to the application of any moneys or other property delivered to, or upon the order of, my said attorney in pursuance of this power. Any act or thing done by my said attorney pursuant to the powers herein conferred upon Joseph Mazurek, prior to express notice of the revocation hereof by operation of law or otherwise, shall be binding upon me, my heirs, personal representatives and assigns.

If any power or authority hereby sought to be conferred upon my attorney should be invalid or unexercisable for any cause or not recognized by any person or organization dealing with my attorney, the remaining powers and authorities given to my attorney hereunder shall nevertheless continue in full force and effect.

I specifically direct that the power of attorney and the discretions, powers and authority herein granted to my attorney shall remain in full force and effect until my death or until such time as I am adjudged incompetent or a disablled person by a court of law.
