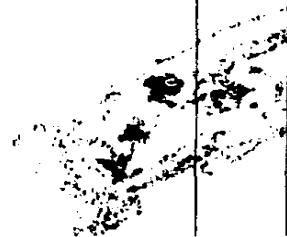
SECTION 13, ARTICLE IV, BYLAWS OF The Northern Trust Company
