AN ORDINANCE VACATING A PORTION
OF FOREST AVENUE

WHEREAS, the Village of Palos Park has received a request to vacate a portion of Forest Avenue as set forth on the Plat of Street Vacation attached hereto and made a part hereof.

WHEREAS, this matter was reviewed at a public hearing and a determination was made by the Village Council that this portion of street is no longer necessary for the health, safety and welfare of the residents of the community, and that a vacation of this street is authorized under Chapter 24, Section 11-91-1, et seq. of the Illinois Revised Statutes.

BE IT ORDAINED BY THE VILLAGE COUNCIL of the Village of Palos Park, Cook County, Illinois:

1. That the following described parcel of property:

That part of dedicated Forest Avenue in Brand's Second Addition to Palos, a Subdivision in the NW 1/4 of Section 25, Township 37 North, Range 12 East of the Third Principal Meridian, according to the Plat thereof recorded December 4, 1903, as document no. 3475933, bounded and described as follows: Beginning at a point on the West Line of Virgil Avenue (as extended) in heretofore described Brand's Second Addition to Palos, that is 14.0 feet South of the North Line of said Forest Avenue and running thence Westerly along the said North Line of Forest Avenue, a distance of 97.50 feet to a point; thence South at right angles to the last described course, a distance of 52.0 feet to a point in the South Line of said Forest Avenue;

thence Easterly along the said South line of Forest Avenue to the West line of said Virgil Avenue; thence North along the West Line (as extended) of said Virgil Avenue, a distance of 52.0 feet to the Place of Beginning, all in Cook County, Illinois.

is hereby vacated.

2. That an Easement is hereby reserved over the Streets so vacated for municipal utility purposes.

3. That the Village Clerk is hereby authorized to file the Plat of Vacation with the County Clerk and obtain all necessary approvals from any governmental agency required prior to recording.

4. This Ordinance shall be in effect from and after its passage and publication in pamphlet form as required by law.
