WHEREAS, The City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of part of public alleys described in the following ordinance; now, therefore,

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. That all that part of the northwesterly-southeasterly 10-foot public alley lying southwesterly of the southwesterly line of Lots 8, 9 and 10 in

Resubdivision of the southeast 20 feet of Sub Lot 2 and Sub Lot 3 to 28 inclusive in Subdivision of Lots 56, 58, 60 and 62 and private alley southeast and adjoining above Lots, in Butterfield's Addition to Chicago, the W. 1/2 of the N.W. 1/4 and the S.E. 1/4 of the N.W. 1/4 of Section 4, Township 39 North, Range 14 East of the Third Principal Meridian;

Clybourn Avenue, N. Larrabee Street, W. Scott Street, and N. Cleveland Avenue as colored in red and indicated by the words "To Be Vacated" on the drawing hereto attached, which drawing for greater certainty, is hereby made a part of this ordinance, be and the same are hereby vacated and closed, inasmuch as the same are no longer required for public use and the public interest will be subserved by such vacuation.

SECTION 2. The vacuations herein provided for are made upon the express condition that within 90 days after the passage of this ordinance, Near North Health Service Corporation shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will accrue to the corner of the property abutting said part of public alleys hereby vacated, the sum of Eight Thousand and no/100 Dollars (\$8,000.00), which sum in the judgment of this body will be equal to such benefits.

SECTION 3. The vacuations herein provided for are made upon the express condition that within 90 days after the passage of this ordinance, the Near North Health Service Corporation shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois, a certified copy of this ordinance, together with an attached drawing approved by the Superintendent of Maps.

SECTION 4. This ordinance shall take effect and be in force from and after its passage.




