The claimant, TRADITIONAL MILLWORK AND SUPPLY, INC., of the Village of Mundelein, County of Lake, State of Illinois, hereby files notice and claim for lien against New Wood Builders, contractor, of the Village of Arlington Heights, County of Cook, State of Illinois, and Mohamed Ali Kahn Iqbal and Asfia Iqbal, his wife and unknown owners 9202 Greenwood Avenue, Niles, IL 60548 of the Village of Niles, County of Cook, State of Illinois, (hereinafter referred to as "owner") and states that on January 15, 1987 the owner owned the land described on Exhibit A attached hereto in the County of Lake and State of Illinois and New Wood Builders was the owner's contractor for the improvement thereof and Zion State Bank and Trust Company and unknown mortgagees was the mortgagee of said premises.

That on January 15, 1987 said contractor made a subcontract with the claimant to furnish labor and materials for \$ 6,468.89 for and in said improvement, and that on March 16, 1987, the claimant completed thereunder all required by said contract to be done consisting of delivery of materials and furnishing of labor to the value of \$ 6,468.89.

That said contractor is entitled to credit on account in the amount of \$ -0- leaving due, unpaid and owing to the claimant after allowing all credits, the sum of \$ 6,468.89, for which, with interest, the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.

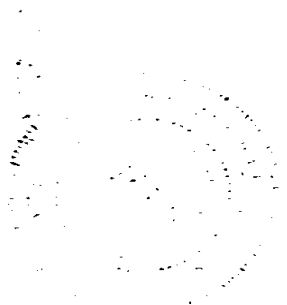
