## Excerpts From Internal Revenue Code

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interest, additional amount, addition to tax or assessable cenalty together with any costs that may accive in addition thereto) shall be a lien in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the tien imposed by section 6321 shall arise at the time the assessment is made and shall continue until the frability for the amount so assessed (or a judgment against the taxpayer arising out of such flability) is satisfied or becomes unenforceable by reason

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security interests, Mechanic's Lienors, And Judgment Lien Creditors, - The lien imposed by section 6321 shall not be valid as against any Duichaser, holder of a security Interest, mechanic's lienar, of juggment lien creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary 🗢 🦤

(a) Release Of Lien. - Subject to such regulations as the Secretary may prescribe, the Secretary shall issue a certificate of release of any lien imposed with respect to any internal revenue tax not later than 30 days after the day on which -

(1) Liability Satisfied or Unenforceable - The Secretary finds that the liability for the amount assessed, logether with all interest in respect thoreof, has been fully satisfied or has
