The notice shall specify: (a) the default; (b) the action required to cure the default; (c) a date, not less than 30 days from the date the notice is given to Borrower, by which the default must be cured; and (d) that failure to cure the default on or 49. Acceleration; Remedies, Lender shall give notice to Borrower prior to acceleration following: (a) Borrower's breach of any coverant or agreement in this Security Instrument (but not prior to acceleration and secular provides otherwise) or the Agreement or (b) Lender's under paragraphs is and 16 unless applicable law provides otherwise) or the Agreement or (b) Lender's
