Upon acceleration and paragraph 16 hereof or anar donment of the Frozeny, and at any time prior to the expiration of any period of recemption following judicial sale, Lender, in person, by agent or by judicially appointed receiver, shall be entitled to enter upon, take possession of and manage the Property and to collect the rents of the Property including those past due. The insurance carrier providing the insurance shall be chosen by Bornwer subject to approval by Lender; provided, that such approval shall not be unreasonably withheld All paemis in surance policies shall be paid by Bornwer making payment, when due, directly to the insurance carrier or the holder of the Prior Mortgage, if required.
