IT IS HEREBY ORDER, ADJUDGED AND DECREED

1. Judgment is entered on behalf of Plaintiff Stone and against Ruth Dahlen in the principal amount of \$68,537.14, plus 14% interest from the November 11, 1985 date of note to today, plus \$870.74, plus costs of this suit, for the total amount of judgment ** \$82,938.40 **, plus costs of this suit.

2. Defendant's affirmative defenses are denied and dismissed with prejudice.

3. Defendant Dahlen's counterclaims against Stone are denied and are dismissed with prejudice, and judgment is entered on behalf of Stone and against Dahlen on said counterclaims.

4. This order is final and appealable, the Court finding that there is no just cause or reason to stay enforcement or execution of this judgment.
