WITNESSETH, that:

Borrower is indebted to Bank in the maximum principal sum of

THIRTY THOUSAND AND NO/100ths---- (\$ 30,000.00) DOLLARS, or the aggregate amount of all advances made by Bank pursuant to that certain Home Equity Line of Credit Agreement between Bank and Borrower ("Loan Agreement") of even date herewith, whichever is less, which indebtedness is evidenced by the Loan Agreement and the Home Equity Line of Credit Variable Interest Rate Promissory Note of oven date herewith ("Note") providing for monthly installments of interest, with the principal balance of the indebtedness, if not sooner paid or required to be paid, due and payable on demand on or after rive (3) years from the date of this Mortgage. However, in no event shall the final payment of the Note, including the total outstanding principal balance and any accrued and unpaid interest, fees and charges, be due later than fifteen (15) years from the date hereof.

Interest on the Note is determined for each monthly billing period by applying a daily periodic rate to each day's ending loan balance. The daily periodic rate may vary from month to month; it is set at the beginning of each monthly billing period and remains constant during that monthly billing period. The daily periodic rate is 1/365th (or 1/366th in the case of leap years) of the Annual Percentage Rate applicable to that monthly billing period (carried to five decimal places). The Annual Percentage Rate will be deterpercent (1.0000%) to the Prime Rate as reported in the Money mined by adding Rate section of The Wall Street Journal on the first business day of such billing period (the "Prime Rate").

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record. The lien of this Mortgage secures payment of any existing indebtedness and future advances made pursuant to the Note to the same extent as if such future advances were made on the date of the execution of this Mortgage without regard to whether or not there is any advance made at the time this Mortgage is executed and without regard to whether or not there is any indebtedness outstanding at the time any advance is made.

The Borrower has the right to prepay the principal amount outstanding of the Note, in whote or in part, at any time during the term thereof, without penalty.

COVENANTS, Borrower and Bank covenant and agree as follows:

- Payment of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on this indebtedness evidenced by the Note.
- 2. Funds for Taxes and insurance. Subject to applicable law or to a written waiver by Bank, Borrower shall pay to Bank on the day monthly installments of principal and interest are payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly taxes and assessments which may attain priority over this Mortgage, and ground rents on the Property, if any, plus one-twelfth of yearly premium installments for hazard insurance, plus one-twelfth of yearly premium installments for mortgage insurance, if any, all as reasonably estimated initially and from time to time by Bank on the basis of assessments and the basis of assessments and the basis of assessments and the basis of assessments.

The Funds she'll be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or state agency (including Balik I Bank is such an institution). Bank shall apply the Funds to pay said taxes, assessments, insurance premiums and ground revits. Bank may not charge for so holding and applying the funds, analyzing said account, or verifying and compiling said assessments and bills, unless Bank pays Borrower interest on the Funds and applicable law permits Bank to make such a charge. Borrower and Bank is ay agree in writing at the time of execution of this Mortgage that interest on the Funds shall be paid to Borrower, and unless such a proment is made or applicable law requires such interest to be paid. Bank shall not be required to pay Borrower any interest or earning, on the Funds. Bank shall give to Borrower, without charge, an annual accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds was made. The funds are piedged as additional security for the sums secured by this Mortgage.

If the amount of the Funds held by Bank, together with the future monthly installments of Funds payable prior to the due dates of taxes, casessments, insurance premiums and ground rents, shall exceed the amount required to pay said taxes, casessments, insurance premiums and ground rents as finy fall due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on monthly installments of Funds, it the amount of the Funds held by Lender shall not be sufficient to pay taxes, assessments, neurance premiums and ground rents as they fall due. Borrower shall pay to Bank any amount necessary to make up the deliciency within 30 days from the late notice is mailed by Bank to Borrower requesting payment thereof.

Upon payment in full of all sums secured by this Mortgage, Bank shall promptly refund to Borrower any Funds held by Bank. If under paragraph 18 hereof the property is sold or the Property is otherwise required by Bank, Bank shall apply, no later than immediately prior to the sale of the Property or its acquisition by Bank, any Funds held by Bank at the time of application as a credit against the sums secured by this Mortgage.

The requirement of this paragraph 2 shall not be applicable if the property is an unbered by a prior first lien mortgage.

- 3. Application of Payments. Unless applicable law provides otherwise, all payments received by Bank under the Note and this Mortgage shall be applied by Bank first in payment of amounts payable to Bank by Borrov or under paragraphs 7 and 18 hereof, then to interest payable on the Note, and then to the principal of the Note.
- 4. Prior Mortgages and Deeds of Trust; Charges; Liens. Borrower shall fully and timely perform all of the Borrower's obligations under any mortgage, deed of trust or other security agreement which has or appears to have any puriod over this Mortgage, including Borrower's covenants to make any payment when due. Borrower shall pay all taxes, assessments and other charges, fines and impositions attributable to the Property which may attain a priority over this Mortgage in the manner provided under Paragraph 2 hereof or, if not paid in such manner, by Borrower making payment, at least ten (10) days before due, directly to the payes thereof. Borrower shall promptly furnish to Bank all notices of amounts due under this paragraph, and in the event Borrower shall make payment directly. Borrower shall promptly furnish to Bank receipts evidencing such payments.
- 5. Hazard Insurance. Borrower shall Reep the improvements now existing or hereafter erected on the Property insured against loss or damage by fire, hazards included within the term "extended coverage", and such other hazards (collectively "Hazards") as the Bank may require. Borrower shall maintain Hazard Insurance for the term of the Note or such other periods as Bank may require and in an amount squat to the lesser of (a) the maximum insurable value of the Property or (b) the amounts of the Line of Credit evidenced by the Note and socured by this Mortgage, plus the amount of any obligation secured in priority over this Mortgage. The Insurance carrier providing the insurance shall be chosen by Borrower subject to Bank's approval which shall not be unreasonably withheld. All premiums on insurance policies shall be paid in the manner provided under Paragraph 2 hereof, or, if not paid in such manner, by Borrower making payment, when due, directly to the insurance carrier. All insurance policies and renewals thereof shall be in a form acceptable to the Bank and shall include a standard mortgage clause acceptable to the Bank. Bank shall have the right to hold the policies and renewals thereof, subject to the rights and terms of any π ortgage, deed of trust or other security agreement with a lien that has or appears to have priority over this Mortgage. Borrower shall promptly funish to Bank all receipts of paid premiums and renewal notices. In the event of a loss, Borrower shall give prompt notice to the insurance carrier and the Bank. The Bank may make proof of loss if not made promptly by Borrower.

- 21. Time of Essence. Time is of the essence of this Mortgage, the Note and the Loan Agreement.
- 22. Release Upon payment of all sums secured by this Mortgage and terministion of the Loan Agreement, Bank shall release this Mortgage without charge to Borrower. Borrower shall pay all costs of records fons of any documentation necessary to release this Mortgage.
 - 23. Waiver of Homestead, Borrower hereby waives all right of homestead exemption in the Property
- 24. Loan Charges, if the loan secured by this Mortgage is subject to a law which sets maximum charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. Bank may choose to make this refund by reducing the principal owed under the Note or by making a direct payment to Borrower.
- 25. Legislation Affecting Lender's Rights. If enactment or expiration of applicable laws has the effect of rendering any provision of the Note or this Mortgage unenforceable according to its terms. Bank, at its option, may require immediate payment in full of all sums secured by this Mortgage and may invoke any remedies permitted by paragraph 18. If Bank exercises this option, Bank shall take steps specified in the second paragraph of paragraph 17.

Subject to the rights and terms of any mortgage, deed of trust or other security agreement with when that has or appears to have priority over this Mortgage, insurance proceeds shall be applied to restoration or repair of the Property damaged, provided such restoration or repair is economically feasible and the security of this Mortgage is not thereby impaired. If such restoration or repair is not economically feasible or if the security would be impaired, the insurance proceeds shall be applied to the sums secured by this Mortgage, with any excess paid to Sorrower. If Borrower abandons the Property, or if Borrower falls to respond to Bank within 30 days from the date notice is mailed by Bank to Borrower that the insurance carrier offers to settle a claim, Bank is authorized to collect and apply the insurance proceeds at Bank's option either to restoration or repair of the Property or to the sums secured by this Mortgage.

If under paragraph 18 hereof, the Property is acquired by Bank, all right, little and interest of Borrower to any insurance policies and to the proceeds thereof resulting from damage to the Property prior to the sales or acquisition shall pass to Bank to the extent of the sums secured by this Mor.gage immediately prior to such sale or acquisition.

- 6. Preservation and Maintenance of Property; Lesseholds; Condominiums; Planned Unit Developments. Borrower shall keep the Property in good repair and shall not commit waste or permit impairment or deterioration of the Property and shall comply with the provisions of any lease if thic Mortgage is on a leasehold. If this Mortgage is on a unit in a condominium or a planned unit development, Borrower shall perform all of Borrower's obligations under the declaration or covenants creating or governing the condominium or planned; unit development, the by-laws and regulations of the condominium or planned unit development rider is executed by Borrower and recorded together with this Mortgage, the covenance and agreements of such rider shall be incorporated into and shall amend and supplement the covenants and agreements of this Mortgage as if the rider were a part hereof.

- 6. Inspection. Bank may make or cause to be made reasonable entrine upon and inspections of the Property, provided that Bank shall give Borrower notice prior to any such inspection specifying reasonable chuze therefor related to Lender's Interest in the Property.
- 9. Condemnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of convertingtion, are hereby assigned and shall be paid to Bank, subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage. Borrower agrees to execute such further documents as may be required by the contemnation authority to effect unter this paragraph. Bank is hereby threvocably authorized to apply or release such moneys received or made settlement for such moneys in the same manner and with the same affect as provided in this Mortgage for disposition or confirment of proceeds of Hazard insurance. No settlement for condemnation damages shall be made without Bank's prior written approval.
- to. Borrower Not Released. Extension of the time for payment, acceptance by Bank of payments other than exceeding to the terms of the Note or modification in payment terms of the sums secured by this Mortgage granted by Bank to any successor in interest of Borrower shall not operate to release, in any manner, the liability of the original Borrower and Borrower's successors in interest. Bank shall not be required to commence proceedings against such successor or release to extend time for payment or otherwise modify amortization of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest.
- 11. Forbearance by Lender Not a Walver. Any forbearance by Bank in exercising any right or remedy hereunder, or otherwise afforded by applicable law, shall not be a waiver of or preclude the exercise of any such right or remedy. A waiver as to one event shall not be construed as continuing or as a waiver as to any other event.
- 12. Remedies Cumulative. All remedies provided in this Mortgage are distinct and cumulative to any other right or remedy under this Mortgage or afforded by law or equity and may be exercised concurrently, independently or successively.
- 13. Successors and Assigns Bound; Joint and Several Liability; Captions. The covenants and agreements herein shall bind, and the rights hereunder shall have to, the respective heirs, legatess, devisess, successors and sesigns of the Bank and Borrower, subject to the provisions of paragraph 17 hereof. All covenants and agreements of Borrower shall be joint and several. The captions and headings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provisions hereof.

- 14. Notices. Except to the extent any notice shall be required under applicable law to be given in another manner, (a) any notice to Borrower shall be given by mailing such notice by certified mail addressed to Borrower at the Property Address or at such other address as Borrower may designate by notice to the Bank as provided herein, and (b) any notice to the Bank shall be given by certified mail to the Bank's address stated herein or to such other address as the Bank may designate by notice to Borrower as provided herein. Unless otherwise specifically provided, any notice provided for in this Micropage shall be deemed to have been given to Borrower or Bank when given in the manner designated herein.
- 15. Governing Law; Severability. This Mortgage shall be governed by Federal law and the law of Illinois. In the event that any provision or clause of this Mortgage or the Note shall be adjudged invalid, illegal or unenforceable by any court, such provision or clause shall be deemed stricken from this Mortgage and shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provision, and to this end the provisions of the Mortgage and the Note are declared to be severable. As used herein, "costs," "expenses," and "attorneys" less" include all sums to the extent not prohibited by applicable taw or limited herein.
- 18. Borrower's Copy. Borrower shall be given a conformed copy of the Note, the Loan Agreement and this Mortgage at the time of execution or after recordation hereof.
- 17. Transfer of the Property; Due on Sale. It all or any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in Porrower is sold or transferred and Borrower is not a natural person) without Bank's prior written consent. Bank may, at its option, require immediate payment in full of all sums secured by this Mortgage.
- If Bank exercises this option, Bank shall give Borrower notice of acceleration. The notice shall provide a period of not less than 30 days from the date the notice is delivered or malled within which Borrower must pay all sums secured by this Mortgage. If Borrower fails to pay these sums prior to the expiration of this period, Bank may invoke any remedies permitted by this Mortgage without further notice or demand on Borrower.

The option granted to Bank under this paragraph 17 shall not be exercised by Bank if such exercise is prohibited by Federal law.

18. Default: Acceleration. The Note and this Nortgage shall be in default after notice by Bank to Borrower of any of the following events: (i) Borrower falls to make any payment due hereunder; (ii) Borrower falls to comply with the terms of the Nore, this Mortgage or the Loan Agreement; (iii) any application or platement furnished to the Bank by Borrower is found to be materially false; (iv) the outstanding halance due Bank under the Note, Mortgage or Loan Agreement exceeds the Principal; (v) Borrower falls to furnish personal financial statements upon request of the Bank from time to time; (vi) Borrower makes an assignment for the benefit of creditors, becomes insolvent or becomes unable to meet Borrower sobligations generally as they become due; (vii) Borrower defaults or an action is filled alleging a default under any credit instrument or mortgage evidencing or securing an obligation of Borrower with priority in right of payment over the Note, or whose item of appears to have priority over the lien created by the Mortgage; (viii) death of Borrower occurs; (ix) there is a sale of the Property; (x) any other act or event occurs by reason of which the Bank reasonably deams itself to be insecure.

Upon default, the Bank at its option may refuse to make any additional estances. Eurither, if any default occurs under sub-paragraphs (i), (ii), (iv) or (ix) above, the Bank shall send notice to Borrower setting forth a time period of at least 30 days within which such default may be cured. If such default is not cured within the time period allowed by the Bank, the entire principal amount outstanding and accrued interest thereon will be immediately due and payable without (in the notice or demand by Bank. If any default occurs under subparagraphs (iii), (vi), (viii), or (viii) above, the Bank at its option may default occurs the entire principal amount outstanding and accrued thereon immediately due and payable. The Note holder may exercise this option to accelerate during any default by Borrower regardless of any prior forbearance.

- 19. Betrower's Right to Reinstate. Notwithstanding Bank's acceleration of the sum is secured by this. Mortgage, Borrower shall have the right to have any proceedings begun by Bank to entorce this Mortgage discontinued at any time, prior to entry of a judgment enforcing this Mortgage it: (a) Borrower pays Bank all sums which would be then due under this Mortgage it: (b) Borrower cures all breaches of any other covenants or agreements of Borrower compliance in this Mortgage; (c) Borrower pays all reasonable expenses incurred by Bank in enforcing the cover and agreements of Borrower contained in this Mortgage and in enforcing Bank's remedies as provided in paragraph 18 flereof, including, but not limited to, reasonable attorneys' fees; and (d) Borrower takes such action as Bank may reasonably equire to assure that the lien of this Mortgage, Bank's interest in the Property and Borrower's obligation to pay the sums secured by this Mortgage shall continue unimpaired. Upon such payment and cure by Borrower, this Mortgage and the obligations secured hereby shall remain in full force and effect as if no acceleration had occurred.
- 20. Assignment of Rents; Appointment of Receiver, Lender in Possession. As additional security hereunder. Borrower horeby assigns to Bank the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 18 hereof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable.

Upon acceleration under paragraph 18 hereof, or abandonment, and at any time prior to the expiration of any period of redemption following judicial sale, Bank, in person, by agent or by judicially appointed receiver, shall be entitled to enter upon, take possession of, and manage the Property, and collect the rents of the Property, including those past due. All rents collected by Bank or the receiver shall be applied first to payment of the costs of operation and management of the Property and collection of rents, including, but not limited to, receiver's foes, premiums on receiver's bonds and reasonable attorneys' fees, and then to the sums secured by this Mortgage. Bank and the receiver shall be liable to account only for those relies actually received.
