THIS INDENTURE, made May 18 19 87, between Michael J. Guardino, a widower

not since remarried - herein referred to as "Mortgagors," and Security Pacific Finance Corporation, an Illinois corporation, herein referred to as TRUSTEE, witnesseth: Del.

THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Instalment Note hereinafter described, said legal holder being herein referred to as Holder of the Note, in the principal sum of 18,606.55

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.

This Trust Deed may not be assumed.
