THIS INDENTURE, made May 18 19 87, between Willie Mae English, N/K/A

Willie Mae Shorter and now married to Theodore Shorter, her husband herein referred to as "Mortgagors," and Security Pacific Finance Corp. a Delaware corporation, herein referred to as TRUSTEE, witnesseth:
