ORDER

This cause coming to be heard on the Citation to Discover Assets served upon Chicago Title and Trust Company and the Citation to Discover Assets served upon Magnolia E. Pye, and this court having entered a judgment in plaintiff's favor against defendant Magnolia E. Pye in the sum of \$170,065.88 plus reasonable attorneys' fees on January 28, 1987, and Chicago Title and Trust Company having disclosed that Magnolia E. Pye is the owner of one hundred percent of the beneficial interest in Chicago Title and Trust Company Trust Agreement dated October 4, 1982 and known as Trust Number 1082657 subject to a collateral assignment of said beneficial interest to Seaway National Bank of Chicago, and that Magnolia E. Pye and Seaway National Bank of Chicago have the power of direction under said Trust Agreement, and this Court being advised in the premises,

IT IS HEREBY ORDERED as follows:

1. Plaintiffs are granted a Lien in the sum of \$170,065.88 plus interest thereon at 9% per annum from January 28, 1987, upon the beneficial interest of Magnolia E. Pye in Chicago Title and Trust Company Trust Number 1082657.

2. Chicago Title and Trust Company is permanently enjoined from making or permitting any sale, assignment, transfer, hypothecation or other disposition of any part of the beneficial interest of judgment debtor Magnolia E. Pye in Chicago Title and Trust Company Trust Number 1082657 and from accepting any assignment of
