

I, NEILS ANDREAS KRUSE, a resident of Park Ridge, Cook County, Illinois, being of sound and disposing mind and memory, do hereby make, publish and declare this to be my Last Will and Testament hereby revoking all former Wills, and Cidicils thereto, by me heretofore made.

ARTICLE 1

I order and direct my Executrix to pay out of the principal of my estate all my just debts, funeral expenses and the costs of administration of my estate. I further direct my Executrix to pay out of the principal of my estate, or to make deposits to secure such segment, and treat as expenses of administration chargeable against my estate generally, all so-called inheritance and estate taxes, including interest and penalties thereon, that may be assessed in any way by reason of my death and I hereby waive on behalf of my estate any right to recover from any person, including any beneficiary of insurance on my life, any part of such taxes so paid.

ARTICLE 11

<u>First:</u> i give, devise and bequeath oil of the remainder of my property, real, personal and mixed, wheresoever located, re my beloved wife, RUTH JACKMAN KRUSE, to have and to hold as her property absolutely.

Second: In the event my beloved wife, RUTH JACKIAAN KRUSE, predeceases me, or in the event my wife, RUTH JACKMAN KRUSE, and I als simultaneously or in the event my wife, RUTH JACKMAN KRUSE, dies within thirty days after my death, I give, devise and bequeath all of the remainder of my property, real, personal and mixed, wheresoever located to my beloved son, NEILS ANDREAS KRUSE, JR., to have and to hold as his property absolutely.

ARTICLE 111

<u>First:</u> I hereby nominate and appoint my beloved wife, RUTH JACKMAN KRUSE, as Executrix of this my Last Will and Testament and direct that she shall not be required to give surety on her official bond.

Second: In the event of the death, resignation, refusal or inability to act of my wife, RUTH JACKMAN KRUSE, I nominate and appoint my son, NEILS ANDREAS KRUSE, JR., as Successor Executor of this my Last Will and Testament and direct that he shall not be required to give surety on his official bond.

Third: I give unto my said Executrix, or her successor, and hereby direct that the same be exercised without requiring leave or direction of any court in that behalf, full power and authority to sell and convey the whole or any part of my said estate, real, personal and mixed, for such prices, on such terms, and to such parties as my said Executrix shall deem best; to extend from time to time, or pay in whole or in part, any note or other abligation existing at the time of my decease; to borrow money for the use of my estate and so pledge or mortgage all or any portion of the property belonging to my estate as security for the repayment thereof; to settle and compound any and all claims either in favor of or against my estate, upon such terms as she may deem proper, and to execute and deliver all necessary and proper documents in evidence or confirmation of any act herein authorized. Serson taking any property from my said Executrix by way of sale, mortgage, pledge or exchange shall be required to see to the application of the proceeds thereof or to inquire as to the authority of said Executrix.

My Executrix is further authorized when she deems such action necessary to the proper protection of the interests of the estate, to join in any plan of reorganization, consolidation, merger or readjustment in respect of any securities belonging to my estate; to accept new securities offered thereunder and to do any acts and to make any payments which may be required to entitle my wrate to the benefits of such plan.
