LOAN MODIFICATION AGREEMENT

WHEREAS, MID AMERICA FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized under the laws of THE UNITED STATES OF AMERICA, and WILLIAM L. STANTON, MARY A. STANTON & MARY MEAHAN (Borrower), entered into an Equity Loan secured by a Mortgage in the amount of TWELVE THOUSAND AND 00/100 ----- (Dollars) evidenced by a Mortgage recorded as Document Number 86546368 in Book N/A, Page N/A, in the office of the Recorder of Deeds of COOK County, Illinois, and

THEREFORE IT IS AGREED, upon the express condition provided, that the Mortgage securing the Line of Credit be extended to 11/3/87. The undersigned hereby promises to pay said indebtedness as stated in Note, namely PRINCIPAL AND INTERST DUE AT MATURITY, NOVEMBER 3, 1987
