AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF FRANKLIN PARK
COOK COUNTY, ILLINOIS (MARCONI SUBDIVISION AREA WEST OF SCOTT)

WHEREAS, the Village of Franklin Park is a municipal corporation of the State of Illinois and is authorized pursuant to Section 7-1-13 of the Illinois Municipal Code (Chapter 24, Ill. Rev. Stats.) to annex territory by ordinance where such territory is less than 60 acres in size and is wholly bounded by one or more municipalities; and

WHEREAS, there is a tract of land situated approximately south of Greenfield Avenue, west of Scott Street, east of the west line of the lots west of Riverside Drive and north of the south line of the lots south of West Manor Drive that is fully surrounded by the Village limits of Franklin Park and is less than 60 acres in size; and

WHEREAS, the said territory is not within the corporate limits of any municipality; and

WHEREAS, legal notices regarding the intention of the Village to annex said territory have been sent to all public bodies required to receive such notice by State Statute; and

WHEREAS, copies of such notices required to be recorded, if any, have been recorded in the office of the Recorder of Deeds of Cook County; and

WHEREAS, all documents and other necessary legal requirements are in full compliance with the Statutes of the State of Illinois, specifically Chapter 24, Paragraph 7-1-13, Illinois Revised Statutes, 1985; and

WHEREAS, it is in the best interests of the Village of Franklin Park that said territory be annexed thereto;

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Franklin Park, Cook County, Illinois, as follows:

SECTION 1. That the following described territory:

The East 458 feet of the South 1286 feet of the Northeast 1/4 of the Southwest 1/4 of Section 28, Township 40 North, Range 12, East of the Third Principal Meridian and the East 33 feet of that part of the Northeast 1/4 of the Southwest 1/4 of said Section 28 lying North of the South 1286 feet thereof

The West 450 feet of the East 908 feet of the South 1286 feet (except the West 53 feet of the South 100 feet thereof) of the Northeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 28, Township 40 North, Range 12 East of the Third Principal Meridian

and

The South 1286 feet of the Northeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 28, Township 40 North, Range 12 East of the Third Principal Meridian in Cook County, Illinois (except the East 908 feet of the North 1186 feet thereof and except the East 855 feet of the South 100 feet thereof)

and

Including that part of the Northeast Quarter of the Southwest Quarter of Section 28, Township 40 North, Range 12, East of the Third Principal Meridian, lying North of the South 1286 feet of said Northeast Quarter of the Southwest Quarter and lying East of the West line of Park Avenue

and

Including the right of way of Greenfield Road and Scott Street and any other right of way required by law to be annexed with such property and including the South 100 feet of the East 125 feet of the Northwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 28, Township 40 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois

and

Excepting from all the above the North 160 feet of Lot 1; the North 160 feet of Lot 22 and the North 175 feet of Lot 23 in Second Addition to Marconi Construction Co.'s West Manor Development, as annexed by Ordinance No. 6566AV3, in Cook County, Illinois

being indicated on an accurate map of the annexed territory, which is appended to and made a part of this Ordinance, is hereby annexed to the Village of Frank Park, Cook County, Illinois.

SECTION 2. That the Village Clerk is hereby directed to record with the Recorder of Deeds of Cook County and to file with the County Clerk a certified copy of this Ordinance together with the accurate map of the annexed territory appended to said Ordinance.

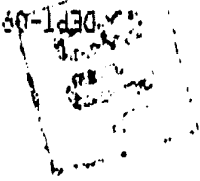
