AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF FRANKLIN PARK COOK COUNTY, ILLINOIS (MARCONI SUBDIVISION AREA WEST OF SCOTT)

WHEREAS, the Village of Franklin Park is a municipal corporation of the State of Illinois and is authorized pursuant to Section 7-1-13 of the Illinois Municipal Code (Chapter 24, Ill. Rev. Stats.) to annex territory by ordinance where such territory is less than 60 acres in size and is wholly bounded by one or more municipalities; and

WHEREAS, there is a tract of land situated approximately south of Greenfield Avenue, west or Stott Street, east of the west line of the lots west of Riverside Drive and north of the south line of the lots south of West Manor Drive that is fully surrounded by the Village limits of Franklin Park and is less than 60 acres in size; and

WHEREAS, the said territory is not within the corporate limits of any municipality; and

WHEREAS, legal notices regarding the intention of the Village to annex said territory have been sent to all public bodies required to receive such notice by State Statute; and

WHEREAS, copies of such notices required to be recorded, if any, have been recorded in the office of the Recorder of Deeds of Cook County; and

WHEREAS, all documents and other necessary legal requirements are in full compliance with the Stattues of the State of Illinois specifically Chapter 24, Paragraph 7-1-13, Illinois Revised Statutes, 1985; act

WHEREAS, it is in the best interests of the Village of Franklin Park that said territory be annexed thereto;

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Franklin Park, Cook County, Illinois, as follows:
