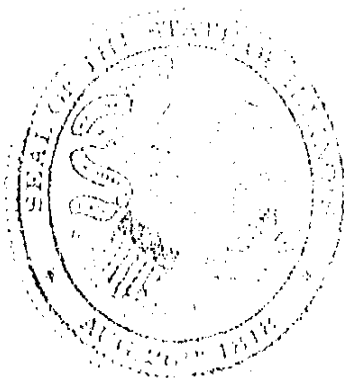
Whereas, ARTICLES OF INCORPORATION OF TRUE FOUNDATION CHURCH
