WHEREAS, The City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of part of public alley described in the following ordinance; now, therefore.

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. That all that part of the east-west 16 foot public alley lying south of the south line of Lots 6 to 11, both inclusive; lying north of the north line of Lot 12; lying west of a line drawn from the southeast corner of Lot 11 to the northeast corner of Lot 12, and lying east of the northwardly extension of the west line of Lot 12, all in

Tomlinson's Subdivision of the North part of Sub-Block of the N.W. 1/4 of Block 11 in Sheffield's Addition to Chicago in Section 32, Township 40 North, Range 14 East of the Third Principal Marginan:

said part of public alley herein recated being further described as the east 124 feet of the first east-west 16 foot public alley such of W. Fullerton Avenue in the block bounded by W. Fullerton Avenue, W. Belden Avenue, N. Racine Avenue and N. Clifton Avenue as colored in red and indicated by the words "To Be Vacated" on the drawing hereto attached, which drawing for greater certainty, is hereby made a part of this ordinance, be and the same is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacation.

SECTION 2. The vacation herein provided for is made upon the express condition that within 90 days after the passage of this ordinance. DePaul University, shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will accrue to the owner of the property abutting said part of public alley hereby causted, the sum of Forty Thousand Five Hundred and no/100 Dollars (\$40,500.00), which sum in the judgment of this body will be equal to such benefits; and further, shall within 90 days after the passage of this ordinance, deposit in the City Treasury of the City of Chicago a sum sufficient to defray the costs of removing paving and curb returns and constructing sidewalk and curb in N. Clifton Avenue. The precise amount of the sum so deposited shall be ascertained by the Commissioner of Public Works after such investigation as is requisite.

SECTION 3. The vacation herein provided for is made upon the express condition that within 90 days after the passage of this ordinance, DePaul University, shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois, a certified copy of this ordinance, together with an attached drawing approved by the Superintendent of Maps.

SECTION 4. This ordinance shall take effect and be in force from and after its passage.
