This Indenture, Made June 8, 1987, between Western National Bank of Cicero, a National Banking Association, not personally but as Trustee under the provisions of a Deed or Deeds in trust duly recorded and delivered to said Bank in pursuance of a Trust Agreement dated June 5, 1987 and known as Trust No. 10224 herein referred to as "First Party," and CHARLES MALLEN, as Trustee- hereinafter referred to as TRUSTEE, witnesseth:

THAT, WHEREAS First Party has concurrently herewith executed One note bearing even date herewith in the PRINCIPAL SUM OF FOUR HUNDRED FIFTY THOUSAND AND NO/100 (\$450,000.00) DOLLARS, made payable to BEARER and delivered, in and by which said Note the First Party promises to pay out of that portion of the trust estate subject to said Trust Agreement and hereinafter specifically described, the said principal sum as follows:

In full accordance with Note dated June 8, 1987 to Affiliated Bank/Western National in the amount of \$450,000.00 executed by IMPERIAL PLATING COMPANY, INC., and all extensions, renewals, or refinancings thereof;

and all of said principal and interest being made payable at such banking house or trust company in Cicero Illinois, as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of AFFILIATED BANK/WESTERN NATIONAL.

In case more than one note is above referred to and described, any reference hereinafter to "note" shall be understood to mean "notes" and any of the rights, powers, privileges and authorities herein granted shall be exercisable by the holder or holders of any one or more of the notes accrued hereby.

NOW, THEREFORE, First Party to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, does by these presents grant, remise, release, alien and convey unto the Trustee, its successors and assigns, the following described Real Estate situate, lying and being in the COUNTY OF Cook AND STATE OF ILLINOIS, to wit:

Lot 6 in Sylvan Woods, a subdivision of the West 100 acres of the South West quarter of Section 34, Township 37 North, Range 11, East of the Third Principal Meridian, (except the North 1349.80 feet thereof), in Cook County, Illinois.
