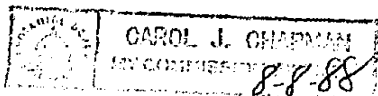

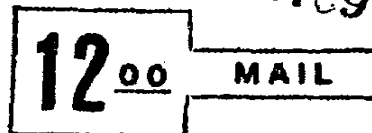

INVESTIGATION OF MURDER

LOCAL NUMBER 00700070

THE FOLLOWING IS A SUMMARY OF THE INVESTIGATION OF THE MURDER OF JAMES EARL RAY, JR. ON APRIL 4, 1968, AT MEMPHIS, TENNESSEE. THE INVESTIGATION WAS CONDUCTED BY THE CHICAGO POLICE DEPARTMENT AND THE FBI. THE RESULTS OF THE INVESTIGATION ARE AS FOLLOWS:

1. THE INVESTIGATION REVEALED THAT JAMES EARL RAY, JR. WAS A WHITE MALE, BORN JANUARY 10, 1928, IN MOBILE, ALABAMA. HE WAS A MEMBER OF THE SOUTHERN CHRISTIAN LEADERSHIP CONFERENCE (SCLC) AND WAS ASSOCIATED WITH THE REV. DR. MARTIN LUTHER KING, JR.

2. THE INVESTIGATION REVEALED THAT JAMES EARL RAY, JR. WAS IN MEMPHIS, TENNESSEE, ON APRIL 4, 1968, FOR THE PURPOSE OF ATTENDING THE SCLC RALLY. HE WAS SEEN AT THE RALLY AND WAS OBSERVED BY SEVERAL WITNESSES. HE WAS ALSO SEEN AT THE HOTEL WHERE HE WAS STAYING.

3. THE INVESTIGATION REVEALED THAT JAMES EARL RAY, JR. WAS IN POSSESSION OF A PASSPORT AND A TRAVEL CHECK. THE PASSPORT WAS ISSUED BY THE U.S. DEPARTMENT OF STATE AND THE TRAVEL CHECK WAS ISSUED BY THE CHICAGO POLICE DEPARTMENT.

4. THE INVESTIGATION REVEALED THAT JAMES EARL RAY, JR. WAS IN CONTACT WITH SEVERAL INDIVIDUALS WHO WERE KNOWN TO BE ASSOCIATED WITH THE SCLC. THESE INDIVIDUALS WERE INTERVIEWED AND THEIR STATEMENTS WERE OBTAINED.

5. THE INVESTIGATION REVEALED THAT JAMES EARL RAY, JR. WAS IN POSSESSION OF A RIFLE AND A SHOTGUN. THESE WEAPONS WERE SEIZED BY THE CHICAGO POLICE DEPARTMENT AND THE FBI.

6. THE INVESTIGATION REVEALED THAT JAMES EARL RAY, JR. WAS IN POSSESSION OF A CARTRIDGE. THE CARTRIDGE WAS SEIZED BY THE CHICAGO POLICE DEPARTMENT AND THE FBI.

7. THE INVESTIGATION REVEALED THAT JAMES EARL RAY, JR. WAS IN POSSESSION OF A LETTER. THE LETTER WAS SEIZED BY THE CHICAGO POLICE DEPARTMENT AND THE FBI.

8. THE INVESTIGATION REVEALED THAT JAMES EARL RAY, JR. WAS IN POSSESSION OF A PHOTOGRAPH. THE PHOTOGRAPH WAS SEIZED BY THE CHICAGO POLICE DEPARTMENT AND THE FBI.

9. THE INVESTIGATION REVEALED THAT JAMES EARL RAY, JR. WAS IN POSSESSION OF A NOTE. THE NOTE WAS SEIZED BY THE CHICAGO POLICE DEPARTMENT AND THE FBI.
