PARTIAL RELEASE OF RIGHT OF WAY EASEMENT ( ) 7 87351007

Subject to the exceptions and reservations hereinafter set forth, MARATHON PIPE LINE COMPANY, a Delaware corporation, being the owner of that certain Right of Way Easement from Nicoleta Coorlas and Thomas C. Coorlas, dated March 7, 1944, and recorded in Book 38944, Page 119, of the Records of Cook County, Illinois, does, in consideration of the sum of Fifty Dollars, paid by George M. Eck to Marathon Pipe Line Company, receipt whereof is hereby acknowledged, release and surrender unto the present owners as their interest appears of record, their heirs and assigns, all of its right, title and interest in and under the aforesaid Right of Way Easement covering the following described lands (hereinafter referred to as "said lands") in the County of Cook, State of Illinois:

The North twelve (12) acres of the west half of the northwest quarter of Section 18, T36N, R13E, of the third principal meridian. ( 28-18-100-001 Harlem )

excepting and reserving from this release, however, a strip of land fifty (50) feet in width across said lands, the centerline of which strip of land is coincident with the centerline of the certain pipeline as presently located and owned and operated by Marathon Pipe Line Company across, in and through said lands, together with the rights of ingress and egress thereto.

It is expressly understood and agreed that Marathon Pipe Line Company reserves all rights in and under said Right of Way Easement as to said above-described strip of land fifty (50) feet in width crossing the land described in said Right of Way Agreement.

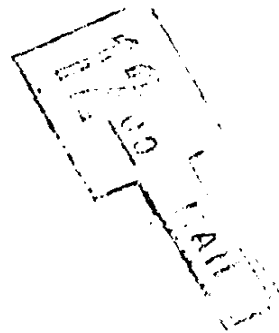
