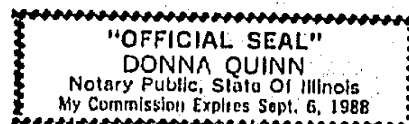

MORTGAGE

THIS MORTGAGE is made this 6th day of March 1978 between the Mortgagor, Sam K. Tortorice and Evelyn J. Tortorice, his wife (herein "Borrower"), and the Mortgagee, Palatine Savings and Loan Association, a corporation organized and existing under the laws of State of Illinois, whose address is 100 West Palatine Road, Palatine, Illinois (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of FIFTY-FIVE THOUSAND AND NO/100ths (55,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated March 6, 1978 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on April 1, 2007.
