THIS MORTGAGE made this 29th day of June, 1987, between ROBERT C. DAVIS and LAURA G. LAVIS, his wife, both of 2020 S. Newton, Park Ridge, Illinois 60068, (hereinafter referred to as "Mortgagor") and the RIVER FOREST STATE BANK AND TRUST COMPANY, (hereinager referred to as "Mortgagee").
