REVOCATION OF LICENSE TO USE A PRIVATE WAY

This Revocation of License is made as of June 30, 1987 by LaSalle National Bank, not personally but as Trustee under Trust Agreement dated December 31, 1986, and known as Trust No. 111921 ("Trustee").

RECITALS

A. Trustee is the owner of certain property located in Cook County and commonly known as 361 West Chestnut Street, Chicago, Illinois, which property is legally described in Exhibit A (the "Property").

B. By license (the "License") recorded October 19, 1959 in the Cook County recorder's office as Document Number 17688849, Trustee's predecessor in interest, Opelika Manufacturing Corporation ("Opelika"), granted to certain persons a revocable license over a private roadway (the "Private Roadway") which constitutes a portion of the Property.

C. The Private Roadway is legally described as follows:

North 10 feet of Lot 2 in Block 29 in Johnston Roberts & Storr's Addition to Chicago, in the North 1/2 of Section 4, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

D. Paragraph 2 of the License provides that the License shall be revocable, at any time, at the option of Opelika or its assigns.

NOW, THEREFORE, pursuant to Paragraph 2 of the License, Trustee hereby revokes the License, effective immediately upon the recording hereof.

This Revocation of License is executed by LaSalle National Bank, not personally but as Trustee as aforesaid, in the exercise of the power and authority conferred upon and invested in it as such Trustee. Nothing in this Revocation of License shall be construed as creating any personal liability or personal responsibility of the Trustee or any beneficiaries of the Trust, and, in particular, without limiting the generality of the foregoing, the owner of any indebtedness or liability accruing hereunder shall look solely to the trust estate, subject to the provisions of the Trust Agreement for payment thereof.


