## REVOCATION OF LICENSE TO USE A PRIVATE WAY

Nothing in this Revocation of License shall be construed as creating any personal liability or personal responsibility of the Trustee or any beneficiaries of the Trust, and, in particular, without limiting the generality of the foregoing, the owner of any indebtedness or liability accuring hereunder shall look solely to the trust estate, subject to the provisions of the Trust Agreement for payment thereof.
