AN ORDINANCE CHANGING THE NAME OF A CERTAIN PUBLIC ROADWAY IN THE VILLAGE OF ARLINGTON HEIGHTS

PLAT WITH THIS DOCUMENT

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ARLINGTON HEIGHTS:

SECTION ONE: That the name of a public roadway lying between Rand Road and Maude Avenue, west of Dryden Avenue, in Arlington Heights, Illinois, being legally described as:

"Beverly Lane" formerly known as Margaret Avenue in C.A. Goelz's Arlington Heights Gardens, being a subdivision in the Northeast 1/4 of Section 20, Township 42 North, Range 11, East of the Third Principal Meridian, in Cook County, Illinois.

an accurate map of which public roadway is attached hereto and made a part hereof, be and the same is hereby changed to Beverly Lane.

SECTION TWO: The Village Clerk is hereby directed to make appropriate changes on the official records of the Village of Arlington Heights in accordance with this ordinance, and to file in the Office of the Recorder of Cook County, a copy of this ordinance together with the map of said public roadway attached hereto; and to send a copy of this ordinance by certified mail, to the post office branch and the election authorities having jurisdiction in the area affected.

SECTION THREE: The Village Manager is hereby directed to erect appropriate signs as indicated in this ordinance to effectuate the purpose of this ordinance.

SECTION FOUR: This ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
