AN ORDINANCE PROVIDING FOR THE ABROGATION OF A CERTAIN PORTION OF AN EASEMENT LOCATED ON THE SOUTHWEST CORNER OF 144TH PLACE AND JOHN HUMPHREY DRIVE, IN THE VILLAGE OF ORLAND PARK, COOK COUNTY, ILLINOIS

WHEREAS, the President and Board of Trustees of the Village of Orland Park, Illinois, after due investigation and consideration, have determined that a certain portion of the easement hereinafter described is not being used by the Village of Orland Park for sanitary sewer purposes and is no longer required for such purpose and that the public interests will be subserved by abrogating said easement; and

WHEREAS, in the opinion of the President and Board of Trustees, the relief to the public from the (u) ther burden of responsibility for and maintenance of said easement shall be adequate compensation for the abrogation of the part of the easement hereinafter described.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Orland Park, Illinois as collows:

### SECTION 1

That the portion of the sanitary sewer easement hereinafter described is no longer required for public use and the public interests will be subserved by abrogating said portion of the easement.

### SECTION 2

That the following portion of the sanitary sewer easement heretofore granted under Easement recorded as Document No. 17988847 in the Office of the Recorder of Deeds, Cook County, Illinois and legally described as follows:
