THIS INDENTURE, made this 7th day of June, 1988, between FIRST UNITED TRUST COMPANY (as Successor Trustee to Oak Park Trust & Savings Bank), a corporation of Illinois, as trustee under the provisions of a deed or deeds in trust, duly recorded and delivered to said company in pursuance of a trust agreement dated the 15th day of May, 1978, and known as Trust Number 8035, party of the first part, and

WITNESSETH, that said party of the first part, in consideration of the sum of \$10 and no/100 (\$10.00) dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said party of the second part, Cook, and State of Illinois, to-wit:
