1. The principal balance of the Note is currently Fifty Five Thousand Four Hundred Seventy Three and 46/100 DOLLARS AND NO/100 CENTS.

2. The maturity of the Note is hereby extended from May 31, 1977 to July 31, 1979.

3. Interest shall be payable on the Note, as extended, at the rate of Eight and 1/2 percent (8 1/2%) per annum. Interest after maturity shall be as aforesaid or otherwise, shall be at the rate of Eight and 1/2 percent (8 1/2%) per annum.

4. Payments shall be in the amount of interest only monthly, beginning on the 1st day of August, 1977, and continuing on the 1st day of each month thereafter. A final payment of the remaining unpaid principal balance and all accrued interest thereon, shall be due on July 31, 1979.

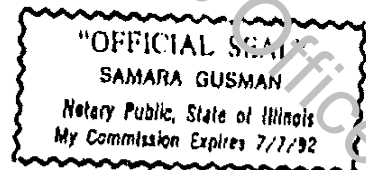

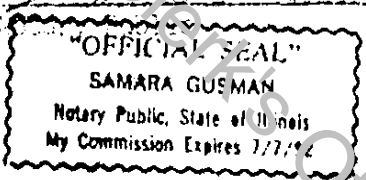
