THIS INDENTURE, made August 31 1988 between Shell J. Bleiweiss and Ben Bleiweiss

herein referred to as "Mortgagors," and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Instalment Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the principal sum of

Four Hundred Fifty Thousand and no cents (\$450,000.00) Dollars,

evidenced by one certain Instalment Note of the Mortgagors of even date herewith, made payable to THE ORDER OF BEARER

and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest from on the balance of principal remaining from time to time unpaid at the rate of 9 1/2 per cent per annum in instalments (including principal and interest) as follows:

Three Thousand Five Hundred Sixty-two & 50/100 Dollars on the 1st day of October 1988, and Three Thousand Five Hundred Sixty-Two & 50/100 Dollars on the 1st day of each month thereafter until said note is fully paid except that the final payment of principal and interest, if not sooner paid, shall be due on the 1st day of September 1993. All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each instalment unless paid when due shall bear interest at the rate of 11 per annum, and all of said principal and interest being made payable at 1204 Michigan Wilmette Illinois, as the holders of the note may, from time to time, in writing appoint, and in Cook County Illinois, as the holders of the note may, from time to time, in said City.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.
