7. Mechanic's Liens. The Mortgagor will pay all claims of mechanics, suppliers and laborers who supply or provide goods or services to the Premises or any portion thereof and will, within thirty days after filing, discharge any lien filed by any such party against the Premises or any portion thereof.

Notwithstanding any rate of interest payable on any such award by the condemning authority, the Mortgagor shall continue to pay interest at the rate specified in the Note or, if the condemnation authority shall make payment of a portion of such interest, an amount equal to the difference between the rate actually paid by such authority and the amount set forth in the Note so that the Mortgagee shall at all times continue to receive interest at the rate specified in the Note as provided therein.

Assignment of Leases and Rents. The Mortgagor hereby assigns to the Mortgagee all leases or other agreements for use or occupancy or any portion of the Premises and the rents, issues and profits (all of said amounts are collectively referred to as "Reits") arising therefrom as further security for the payment of the Note which assignment shall continue in effect until the Note is paid in full.
