## SOUTH BARRINGTON PARK DISTRICT ANNEXATION OF LAND

WHEREAS, the South Barrington Park District is operating within territory predominately in the Village of South Barrington; and

Section 1. The Board of Park Commissioners of the South Barrington Park District hereby finds that the statements contained in the Preamble to this Ordinance are true and correct.

Section 2. The following described territory is hereby annexed to the South Barrington Park District:

The West half of the Southwest Quarter of Section 22, Township 42 North, Range 9 East of the Third Principal Meridian (except that part in the Northwest corner lying West of the center of public highway and except that part of said tract described as follows: Beginning at the Southeast corner of said tract thence North along too East line of said tract 726 feet; thence West parallel with the South line of said tract 300 feet; thence South parallel with the East line of said tract 726 feet to the South line of said tract; thence East along said South line to the place of beginning);

Together with all tost part of the right of way of Penny Road lying South of and adjoining the above described property and all that part of the right of way of Bartlett Road lying West of and adjoining the above described property, all in Cook County, Illinois.

Or also described as:

The West half of the Southwest Quarter of Section 22, Township 42 Morth, Range 9 East, of the Third Principal Meridian; except the East 300.00 feet of the South 726.00 feet thereof; containing 75.079 acres, more or less; in Cook County, Illinois
