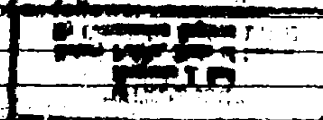
That on June 20, 1988, said contractor made a subcontract with the claimant to install certain fencing and deck on the subject property

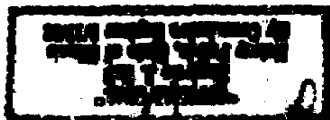
