THIS CONSTRUCTION LOAN MORTGAGE (this "Mortgage") is made this 1st day of August . 1988, between Chicago Title and Trust Company . not personally but as Trustee under Trust Agreement dated April 16, 1980 and known as Trust Number 48-69948-2 and Theophilus B. Gray and Inex M. Gray ("Mortgagor"), and Residential Energy Conservation Loan Fund, an Illinois not-for-profit corporation whose address is 111 East Wacker Drive, Eighth Floor, Chicago, Illinois 60601 ("Mortgagee").

WHENEAS, Mortgagor and Chicago Title and Trust Company

NOW, THEREFORE, Mortgagor, to secure payment of the indebtedness due or to become due parsuant to the Note and this Mortgage, and the performance of the covenants herein and therein contained to be performed kept and observed by Mortgagor, and for other good and valuable consideration, the receipt and sufficiency of which is herely acknowledged, does hereby MORTGAGE, GRANT AND CONVEY unto Mortgagee, its successors and assigns, the real estate situated in the City of Chicago, County of Cook and State of Minois, as more particularly described in Exhibit B attached hereto and made a part hereof;

- 1. Payment and Compliance with Note. Mortgagor will duly and punctually pay all principal and interest due on the Note and any late charges required thereunder, and the principal of, and interest on, any Future Advances (as hereinafter defined) secured by this Mortgage, and will otherwise comply with the terms and conditions of the Note, at the times and in the manner therein provided.


