AMENDMENT TO ASSIGNMENT OF MORTGAGE AND CERTAIN OTHER LOAN DOCUMENTS

THEREFORE, IT IS HEREBY AGREED by Republic and CFC that the name of "Chemical Financial Services, Inc., its successors and assigns" as written on the Assignment dated Sept. 23, 1987 and recorded on Nov. 5, 1987 as Document No. 87598175 is to be deleted and that the Assignment be amended by inserting the name of "Chemical Financial Corporation, its successors and assigns" in its place.

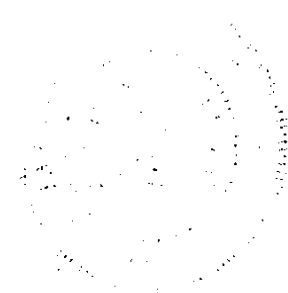

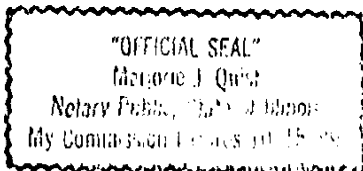
