THIS TRUST DEED, made SEPTEMBER 22 19 88, between

NICHOLAS J. MONTOUR AND PAMELA J. MONTOUR, h-w

herein referred to as "Mortgagors," and LINDA H. KTSANES, of

COOK County, Illinois, herein referred to as TRUSTEE, witnesseth THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Promissory Note (herein called "Note") hereinafter described, said legal holder or holders being herein referred to as

Holders of the Note evidenced by one certain Promissory Note of the Mortgagors of even date herewith, made payable as stated therein and delivered,

in and by which said Note the Mortgagors promise to pay an Amount Financed of SIX THOUSAND ONE HUNDRED DOLLARS

AND THIRTY SEVEN CENTS (6,100.37) Dollars with interest thereon, payable in installments as follows:

ONE HUNDRED FIFTY NINE DOLLARS AND NINETY THREE CENTS (159.93) Dollars or more on the 27th day

of OCTOBER, 19 88, and ONE HUNDRED FIFTY NINE DOLLARS AND NINETY THREE CENTS (159.93)

Dollars or more on the same day of each month thereafter, except a final payment of 159.93 Dollars, until said Agreement

is fully paid and except that the final payment, if not sooner paid, shall be due on the 27th day of SEPTEMBER, 19 93

NOW, THEREFORE the Mortgagors to secure the payment of the said sum of money in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the COUNTY OF COOK AND STATE OF ILLINOIS, to wit:

THE SOUTH THREE (3) FEET OF LOT EIGHT (8) AND NORTH FOUR (4) FEET OF LOT TEN (10) IN BLOCK TWENTY (20) IN CRANE VIEW ARCHER HOME ADDITION TO CHICAGO, A SUBDIVISION OF THE WEST HALF OF THE WEST HALF (EXCEPT THE NORTH NINE (9) AND TWO HUNDRED TWENTY FIVE ONE THOUSANDTHS (9.225) ACRES AND EXCEPT A SIXTY SIX (66) FOOT STRIP ACROSS THE WEST HALF OF THE SOUTH WEST QUARTER OF SECTION NINE (9) FOR RAILROAD) IN SECTION NINE (9) TOWNSHIP THIRTY EIGHT (38) NORTH, RANGE THIRTEEN (13) EAST OF THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

All of the foregoing are declared to be a part of said real estate whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment or articles hereafter placed in the premises by the mortgagors or their successors or assigns shall be considered as constituting part of the real estate.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns forever, for the purposes and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.

THIS TRUST DEED MAY NOT BE ASSUMED WITHOUT THE WRITTEN CONSENT OF THE LEGAL HOLDERS OF THE NOTE THAT THIS TRUST DEED SECURES.

This trust deed consists of two pages. The covenants, conditions and provisions appearing on page 2 (the reverse side of this trust deed) are incorporated herein by reference and are a part hereof and shall be binding on the mortgagors, their heirs, successors and assigns.
