AN ORDINANCE  
ANNEXING CERTAIN TERRITORY  
TO THE VILLAGE OF PALATINE  
(GAGLIANO AND HIDDEN HILL PROPERTY)

WHEREAS, the Owners of record of the following described territory have petitioned that said territory be annexed to the Village of Palatine, Illinois, and

WHEREAS, the Municipal Authorities find and have determined that said territory is contiguous to the Village of Palatine, and

WHEREAS, the Palatine Rural Fire Protection District has been duly notified in writing more than ten (10) days in advance of consideration of this ordinance, pursuant to statutes:

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Palatine, acting in the exercise of their home rule power:

SECTION 1: That the following territory:

The South 495 feet (except the east 471.43 feet thereof) of the Northeast 1/4 of the southeast 1/4 of Section 16, Township 42 North, Range 10, East of the Third Principal Meridian, also known as the south 495.0 feet (except the east 471.43 feet thereof) of Lot 9 of School Trustee's Subdivision (except from said south 495.0 feet that part, if any, which falls in the north half of the north half of the southeast 1/4 of the northeast 1/4 of the southeast 1/4 of Section 16, aforesaid). Together with all of Middleton Avenue and all of Wood Street lying west of and adjoining and south of and adjoining, respectively, the above described tract.

The south 495 feet of the east 471.43 feet of the northeast 1/4 of the southeast 1/4 of Section 16, Township 42 North, Range 10, East of the Third Principal Meridian (also known as the south 495.00 feet of the east 471.43 feet of Lot 9 of School Trustee's Subdivision), (except from said 495 feet that part, if any, which falls in the north half of the north half of the southeast 1/4 of the northeast 1/4 of the southeast 1/4 of Section 16 aforesaid, (also except therefrom the south 258 feet of the west 150 feet thereof), together with all of Quentin Road and all of Wood Street lying east of and adjoining and south of and adjoining, respectively, the above described tract.
