

## AMENDMENT TO ASSIGNMENT OF MORTGAGE AND CERTAIN OTHER LOAN DOCUMENTS

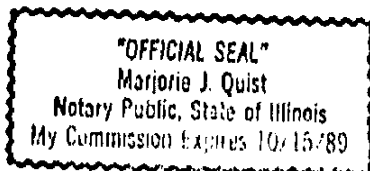
