WITNESSETH, that said party of the first part, in consideration of the sum of ten and no/100 (\$10.00) dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part,

the following described real estate, situated in Cook County, Illinois, to-wit:

Lot 4, in Starkley Subdivision, being a subdivision in the West 1/2 of the South West 1/4 of Section 34, Township 42 North, Range 12 East of the Third Principal Meridian, more particularly described as follows:

Commencing at the North West corner of the South West 1/4 of said Section 34, thence Easterly along the North line of the South West 1/4 of said Section 34, a distance of 717.76 feet, to the point of beginning, thence Southerly along the East line, and the Northerly extension of the East line of Golf Meadows subdivision, a distance of 728.79 feet to the North line of Golf Meadows, Unit Number 2, recorded December 15, 1963, as Document Number 15792571; thence Easterly along the North line of said Golf Meadows, Unit Number 2, a distance of 301.19 feet, thence Northerly at right angles, to the previously described line, a distance of 728.65 feet to the said North line of the South West 1/4 of Section 34; thence Westerly along said North line of the South East 1/4 of Section 34, a distance of 300.84 feet to the point of beginning, except the Northerly 33 feet thereof, in Cook County, Illinois.


