13. Trustee shall release this trust deed and the here thereof by proper instrument upon presentation of satisfactory evidence that all indebteness secured by this trust deed has been fully paid; and Trustee may execute and deliver a release hereof to an a at the request of any person who shall, either before or after maturity thereof, produce and exhibit to Trustee the note, representing that all indebtedness hereby secured has been pully, which representation Trustee may accept as true without inquiry. Where a release is requested of a fuccessor trustee may accept as the genuine note herein described any note which bears an identification number purporting to be executed by the persons herein designated as the makers thereof; and where the release is requested of the note and with his instrument in writing filed in the office of the Recorder or Register of Titles in which this instrument shall have the reasons herein designated as makers thereof.

14. Trustee may resign by instrument in writing filed in the office of the Recorder or Register of Titles in which this instrument shall have

fersons herein designated as makers thereof.

44. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrict of Titles in which this instrument shall have been recorded or filed. In case of the resignation, inability of refusal to act of Trustee, the then Recorder of Deeds of the county in which the premises are situated shall be Successor in Trust. Any Successor in Trust hereunder shall have the idential title, powers and authority as are herein given Trustee.

15. The word "note" when used in this maximum shall be construed to mean "notes" wher more than one not; is used.
