Mortgagor and Guarantor shall not permit any of the Rents to be collected in advance, except that any monthly rent due and payable under the Leases may be collected up to 15 days in advance. Nothing contained herein shall be deemed to have the effect of making the Lender a mortgagee in possession of the Mortgaged Premises or any part thereof.
- 4.6 Reimbursement. Mortgagor and Guarantor shall reimburse, indemnify and hold harmless Lender for and from any and all expenses, losses, lamages and liabilities which Lender may incur by reason of this Assignment of Leases and Rents, any of the Leases, or expenses, losses, damages and liabilities incurred in exercising any of the rights granted in this Assignment of Leases and Rents. Any and all amounts due to Lender under this Section 4.6 shall be immediately due and payable, shall be added to the principal amount of the Note and secured by this Assignment of Leases and Rents and the Other Lien Agreements.
