COOK County Illinois, to wit:

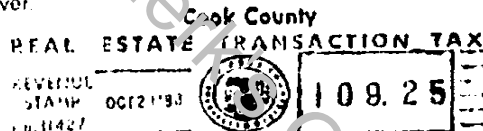
